We would herewith like to cordially invite you to the above-mentioned event and hereafter provide you and your national federation with a first range of information.

First, we kindly ask the federation concerned to confirm participation of their referees to the Head Office in Basle no later than 23 October 2012 with help of the NF participation form (Click 'NF participation form' to access the file; after having completed the form please click 'submit' to forward the form to the IHF). Furthermore, we kindly ask the referees to fill in the referee participation form and the adidas size check to be returned to the IHF Head Office no later than 23 October 2012 (Click 'referee participation form' and 'adidas size check' to access the file; after having completed the form please click 'submit' to forward them to the IHF). Based on your home airport you submit, the Spanish organiser will work out the travel arrangements.

As mentioned above, the WCh will be held from 11 to 27 January 2013. All IHF nominees will arrive to Spain on 8 January 2013. Preparatory measures including mini-course, outfitting, settlement of payments, etc. will be staged on 9/10 January 2013. Departure will be fixed individually, either after the eighth-finals/President's Cup or on 28 January (after the finals). Further details in this regard will follow at a later stage.

The referees are advised to stay active between now and the event with strong physical preparations in order to pass the fitness tests. We kindly ask the national chief referees to
